2. In the event the pet produces a litter, I agree to keep them at the rental premises no longer than one month past weaning. If any HOA or Condo association guidelines prohibit litters, I agree to remove all additional pets from the premises immediately.
3. I shall not engage in any commercial pet-raising activities.
4. There shall be no other pets, other than listed above on the premises without the express written approval of Landlord. Should I desire additional pets, I agree to apply to Landlord for approval, prior to pet occupancy.
5. I agree to keep the pet from becoming a nuisance to neighbors. This includes controlling the barking of the pet, if necessary and cleaning up any animal waste.
6. In the event that my pet causes damage or destruction to the property, I agree that all cost of said damage or destruction shall come out of our security deposit as stipulated in the lease agreement. Should the security deposit be insufficient to cover the cost of any pet damage or destruction, then I agree to be financially responsible for damages above and beyond the amount of my security deposit.
7. If the pet becomes a nuisance or causes damage or destruction to the premises or otherwise violates the terms of this pet application, Service Star Realty may terminate the pet's right of occupancy and/or my/our lease agreement.
